

# Prysmian / Encore Wire Privacy Policy

Last updated January 12, 2026

## Summary

This Privacy Policy describes how we collect, use, and share your personal information and the choices you may have regarding our use of your personal information. We may update and make changes to this policy, so we encourage you to review it periodically.

**1. Collection of Personal Data.** We do not collect personal identifiers from visitors to our website. We do utilize several cookies to gather anonymous and aggregated network activity information from visitors, as described further below in the Cookie Policy.

**2. Use of Personal Data.** We use anonymous and aggregated network activity to monitor traffic to and activity on our website.

**3. Categories of Personal Data Shared with Third Parties.** We have shared anonymous and aggregated network activity with the third parties who provide us with the cookies used to monitor traffic and activity on our website.

**4. Sharing Personal Data.** We may share anonymous and aggregated network data with:

- Our affiliates, including companies within the Prysmian group and other third parties we use to help us run our business, such as website hosts.
- We only allow our service providers to handle such data if we are satisfied, they take appropriate measures to protect the data. We also impose contractual obligations on service providers, contractors, and third parties to ensure they can only use the data to provide services to us and to you.
- We may disclose and exchange information with law enforcement agencies and regulatory bodies to comply with our legal and regulatory obligations.
- We may also need to share some data with other parties, such as potential buyers of some or all of our business or during a restructuring. The recipient of the information will be bound by confidentiality obligations.
- We do not share your data with any other third party.

**5. Sales and Targeted Advertising.** We do not sell any personal data or process any personal data for the purpose of targeted advertising.

**6. Rights Under the TDP SA.** Since we do not collect any personal data from our customers or visitors to our website, the rights provided under the Texas Data Privacy and Security Act ("TDP SA") or other state law are inapplicable.

**7. Cookie Policy.** Like many companies, we use various technologies, including cookies, to collect and store anonymous information about visitors to our website. These technologies perform similar functions to help us operate our website and serve you better. The use of cookies on our website creates a faster and easier experience for the user, while also allowing us to learn about your interactions, conduct analytics activities, and improve our website.

- For example, our website uses Google Analytics, which is a web analytic tools provided by Google, Inc. This service uses cookies to help our website analyze how users use the website. The information generated by the cookies about your use of the website (including your IP address) will be transmitted to and stored by this vendor and similar vendors on servers in the United States. These vendors will use this information for the purpose of evaluating your use of the website, compiling reports on website activity, and providing other services relating to website activity and internet usage. These vendors may also transfer this information to third parties where required to do so by law, or where such third parties process the information for the vendors to provide those services. You may refuse the use of cookies by selecting the appropriate settings on your browser. However, if you do block the use of cookies, you will not be able to use the full functionality of the website.
- Our website only utilizes cookies that can be described as "strictly necessary" or "performance and analytics cookies." Strictly necessary cookies are necessary to enable you to move around the website and use its features. Performance and analytics cookies collect information about how many visitors come to our website, how visitors use our website, and how we can optimize our site based upon, for instance, which pages visitors use most often and if they encounter error messages from certain web pages. We use third parties to assist us in analyzing this data. These cookies do not collect information that identifies a visitor, as all information these cookies collect is aggregated and anonymized.
- There are various ways for you to manage cookies and other technologies. Through your browser settings, you can disable all the above-listed cookies (and other tracking tools) or request to be prompted before accepting cookies from the website and other websites you visit. These browser settings may also permit you to delete cookies you already have.
